REF: ATTACHED DOCUMENTATION PERTAINING TO: COUNCILLOR LYNDA WHITE VS. FORMER COUNCILLOR ANDREW JOHNSON (WARD 6)

To expand upon my letter to Council, Dated March 31st, 2007 (Copy Attached), and my Final Presentation to Council of 26TH APRIL 2007, I am of the expressed opinion, I have a Moral, Ethical and Civic Duty to set down for the Public Record, the details and related status of this Criminal Act's, blatant and intentionally planned process of obscurity, to the Public's "entitlement to know!"

By uncanny co-incidence, Friday September 28th 2007 was "International Right to Know Day."

I enclose a copy of the Guelph Mercury's published (2) page message to assure the People of Guelph, that the Editors and Staff of that Local Newspaper Endorse the Basic Fundamentals Of Democracy (i.e.) The Public Right to Know! I applaud Mr. Phil Andrews, Managing Editor, for his impeccable timing of publication, with a Personally Experienced Exposure to the Professional Ethics and Sense of Civic Duty, shared by Mr. Andrews and His Total Team. Thank You, and keep up the Great Work!

Building on the "Right to Know" entitlement, the Saga of Councillor Lynda White Vs. Ex-Councillor Andrew Johnson, is a clear example of County Government's abuse of the Taxpayer's "Right to Know," and culminating in a Criminal Act of Misappropriation of Public Funds, committed with intent to "buy silence" from a Victim of the County Council "Star Chamber" Membership. This Group, knowingly and with preconceived purpose, thought they could "Buy Off" Mr. Andrew Johnson, by entrapping him into an agreement to

be part of an Illegal Financial Settlement, purposely planned to be hidden from Public and County Council View!

As I have, in my letter to Council dated March 31st, 2007 (Copy Attached) clearly and definitively, detailed the facts, which led up to the perpetration of the Crime of Breach of Trust of an Official, **SECTION 122 OF THE CRIMINAL CODE**. Up until then the issue was Personal between Two Councillors, and clearly responded to by Mr. Hugh Guthrie QC, Counsel of Record for the County of Wellington, in his letter to Both Councillors **DATED 26TH MAY 2006** (Copy Enclosed).

The whole scene was changed by the subsequent involvement of then Warden Whitcombe, which resulted in a County Council Involvement!

In an effort to minimize the extent of this letter, I would request the Reader to consult the letter attached, dated March 31st 2007, for an Audit Trail of events and their correlation to the crimes committed by Warden Whitcombe (**ET AL**).

For the Record, as stated in my March Letter, I refrained from “Throwing Gasoline on a Raging Fire” when I was appraised of a letter written by Mr. Andrew Johnson, during a Telephone Call from Me to Him on the evening of **MARCH 28TH 2007**, with my purpose to **STRONGLY CHASTISE** him for his “Apathy” with the Lynda White Lawsuit and his planned non attendance at the Council Meeting next day.

Mr. Johnson was taken by surprise by my contempt for his lack of, my perceived, sense of duty from him and Responsibility to the Taxpayers. I now know that I was Totally Unfair in my Attack, that is what it was! Mr. Johnson informed me that he had conformed to the Professional and Ethical Protocol required in these Proceedings by writing a letter to **C.A.O. MR. SCOTT WILSON** on June 1st 2006 (**COPY ATTACHED**). Mr. Johnson expressed surprise that I, as a member of the Public had not received a Copy of the Letter, and proceeded to read the Letter to me over the Phone. To say the least, I was **APPALLED** and **ASTOUNDED!**

Mr. Johnson offered to send me a Copy which I declined, only because of the Timing! My reason to decline was twofold, first my fax machine was down and I couldn't receive the Faxed Letter in Time to present to the Now Warden, John Green, who I thought would have no knowledge of the letter. I based this analyses on his perceived confusion with the state of events, related to the issue, and my belief in Mr. Green's Integrity and Honour.

I expressed to Mr. Johnson my interpretation of the fact that Warden Green was totally oblivious to the Letter and Mr. Johnson's Honourable Intentions to follow Protocol and seek the co-operation of the **C.A.O. MR. WILSON** in Mr. Johnson's Request to seek Full County Council's concurred Process to guide Councillor Johnson through the situation, and still Ethically and Professionally serve the People of Wellington, as a Councillor, despite impending Legal Proceedings, thrust upon him by a Fellow County Councillor. As a resolution to the problem, and with my personal Scheduled Presentation to Council next morning, I requested thus of Mr. Andrew Johnson. As my Fax Machine was Down:

Please Fax a Copy of Mr. Johnson's Letter, Dated June 1st to Councillor Maieron, and request Mr. Maieron to receive the letter, and Hand Deliver the Letter to Warden Green. The steps were duly completed as planned, and witnessed by me, early **A.M.** on Thursday March 29th 2007, when Mr. Maieron delivered Mr. Johnson's Letter Copy to Warden John Green in the Parking Lot at Council.

It is very significant to understand and recognized, that Mr. Maieron delivered to Warden Green, on **THURSDAY MARCH 29TH 2007** Mr. Johnson's Letter to Mr. Scott Wilson Dated **JUNE 1ST 2006**, with respect some (9) Month's Later! With my respect for Mr. John Green, upon the commencement of my scheduled address to Council on 29th March I requested a (1) Month's Adjournment of my Presentation, to enable the Warden to put his House In Order. It is fair to say, I was by far, **TOO GENEROUS AND RESPECTFUL**, as now some (6) Months Later, I am **FORCED** to write this Letter. This from a C.A.O. who is Charged, by Charter, to Perform within the Laws and **ENSURE** the said Laws are implemented and followed to the letter!

Mr. Warden, Ladies and Gentlemen, I must **INSIST** the man be **FIRE**D from his position of C.A.O. of this Council. (I.e.) No Resignation, Equals No Severance! Payment of Mr. Johnson's Legal Costs, to "Make this thing Go Away," without Council, or worse, Public Disclosure! Very, Very, Serious Crime!

There is no place in Local Government for this **BEHAVIOUR**! As you know Mr. Warden, I can bring up the Freedom Of Information Tribunal (Pending) on this issue, but I will keep that, for Court Proceedings against the Other Related (Alleged) Criminals! Yes, Mr. Warden, **I AM** Angry, and with Respect, **SO SHOULD YOU BE**!

Do your Duty Mr. Warden! **FIRE** the Man!!
